ANNUAL MEETING – Australian Ballot

The legal voters of the Village of Hyde Park are hereby notified and warned to meet at the Town Community Room in the Village of Hyde Park on Tuesday, May 3, 2022 to transact the following business by Australian ballot. Said voting by Australian ballot to begin at 9:00 am and close at 7:00 pm.

- Article 1. To elect a President for the ensuing year.
Article 2. Will the Village voters approve the summarization of minutes of the 2021 Annual Meeting?
Article 3. To elect a Trustee of the Bliss Library Fund for a term of three (3) years
Article 4. To elect a Village Trustee for a term of two (2) years
Article 5. To elect a Village Trustee for a term of three (3) years
Article 6. To elect a Trustee of the Bliss Library Fund one (1) year of remaining three (3) year term
Article 7. Will the Village voters approve a budget and authorize taxes at the rate of .09%/\$100, to be used for operations of the General Department?
Article 8. Will the Village voters set a due date of August 31, 2022 for Village Taxes and an interest percentage of 1 percent (1%) for the first three months and thereafter, one and one half percent (1 1/2%) and an eight percent (8%) penalty for delinquent taxes?
